## **Finance/Property**

- Refinance of mortgages
- Transfers of land for gifts, trusts, family law arrangements
- Caveats
- Land Titles Office applications to remove caveats
- In house mortgage broker to help with refinance of mortgage with current lender (or find new lender) for a purchase

## **Legal Aid Matters**

- Simplified Grants Process Panel –Family Law and Intervention orders (approval of funding within 24 hours for 99% of cases so work can start immediately on day of interview if legal aid approved)
- Standard Legal Aid application for all other types of matters
- Interstate Legal Aid matters

## **Personal Injury**

- Victims of crime (VOCAT)
- Work injuries and other civil claims
- Death and class action claims (check with our referral list)

## **Probate**

- Acting for executors of wills
- Acting for personal representatives where there is no will
- Supreme Court disputes over wills or the distribution of estates
- Part IV Claims (Family Provision for family members left out of will)
- Survivorship applications (transfers between joint owners when one has died)

## **Power of Attorney**

- Legal and Financial
- Medical
- Guardianship issues and VCAT
- General enduring or specific powers

## **Wills**

- Simple wills
- Mirror wills for husband and wife
- Mirror wills for domestic partners
- General estate planning
- Complex wills with testamentary trusts to keep assets within the family
